In April 2025, expenditures exceeded revenues by \$14,789. The budget for April 2025 is an excess of \$16,369. Year-to-date (YTD) through April 2025, expenditures exceeded revenues by \$747,322. The budget YTD through April 2025 is a loss of \$21,779.

## IV. Executive Director Report. - Pam Gutierrez, Executive Director

- The HCS Wait list currently has 3,279 individuals waiting for services.
- The IDD General Revenue Wait list currently has 312 waiting for services.
- Mental Health Adult Services continues not to have a wait list.
- Mental Health Child and Adolescent Services continues not to have a wait list.
- We are anxiously waiting for Legislature's decision on State Representative Ben Bumgarner's amendment, which has passed the House and the Senate. It is currently in Committee.
- The Center continues to look for funding opportunities, in particular due to all of the funding losses it is important to remember as discussed at the last meeting, that the Center is freezing positions, reviewing every program, including the Crisis Residential Unit (CRU) to determine effectiveness and efficiency. The Integrated Health program will be closing towards the first of July 2025. In addition, the Center continues to eliminate positions if the position is not needed at this time.
- We continue to meet with Mayors from local municipalities to discuss Center services and funding opportunities. We have not received any funding yet, but we continue to work on this.
- May is Mental Health Month, and the Mental Health Proclamation was on May 6<sup>th</sup> at the Denton County Courthouse, with many of you in attendance and so many staff. Thank you for your support!
- Our Child and Adolescent program continues to look for donations for their new area. Crayons, boardgames, coloring books, markers, sensory items, building blocks. The Amazon link is included on your flyer.
- The Annual LOSS Team Music & Arts Fest will be held on June 14, 2025, at Anderson's Distillery, N Bell Ave, Denton, Texas, 12:00pm to 8:00pm. Please come out and support the incredible LOSS Team!
